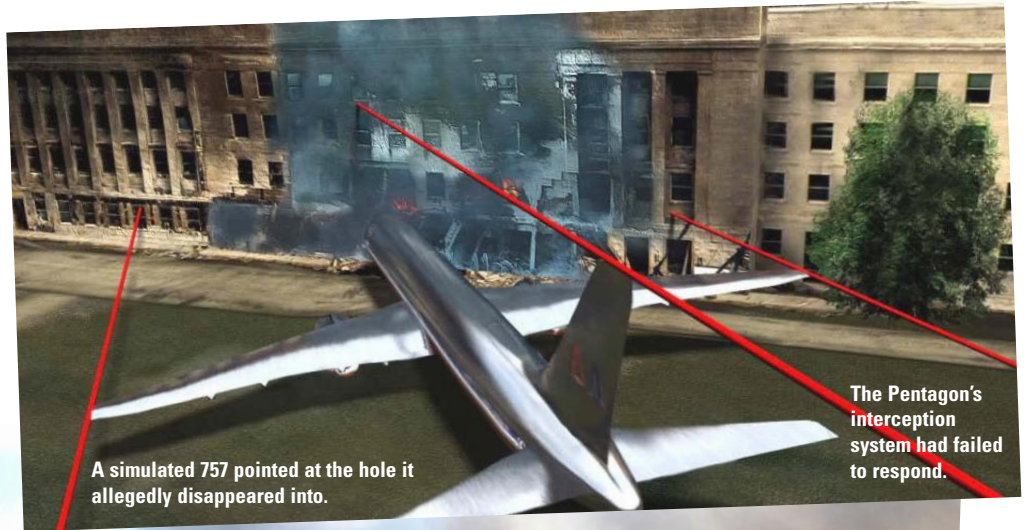


How did a Boeing 757 disappear in a 5 Metre / 16 Ft hole?



A simulated 757 pointed at the hole it allegedly disappeared into.

The Pentagon's interception system had failed to respond.

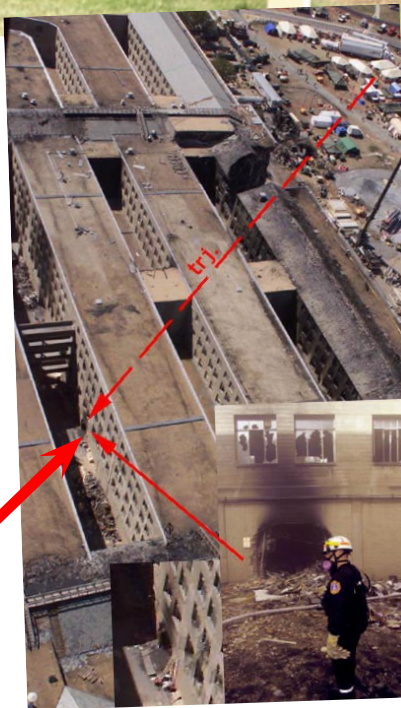
Why is there No: 757 wreckage? Fuselage? Tail fin? Engines?



The lawn and oddly no wreckage. The building collapsed later.

9/11 Commission Answer:

- The wings and the engines folded back to pass through the hole into the building!
- The lightweight nose compacted to pierce through six half-metre thick reinforced walls!
- The plane then vapourised in the heat!



John W. Brown from Rolls Royce (makers of engines for 757's) said, "It is not a part from any Rolls Royce engine that I'm familiar with".

The alternative Pratt & Whitney PW2043 engine, used on some 757 aircraft, has a fan tip diameter of 78.5 inches. **Nothing this large is to be seen in the FEMA photographs.**

The plane approach - a 7,000 ft drop 270° turn - in 2 1/2 minutes!

Air traffic controller Daniel O'Brien told ABC News "the speed, the maneuverability, the way that he turned, we all thought in the Radar Room, all of us experienced air traffic controllers, that **that was a military plane.**"

Why did WTC 7 collapse?

The structure remained undamaged all day long ...

the Twin Towers had collapsed 100m away.

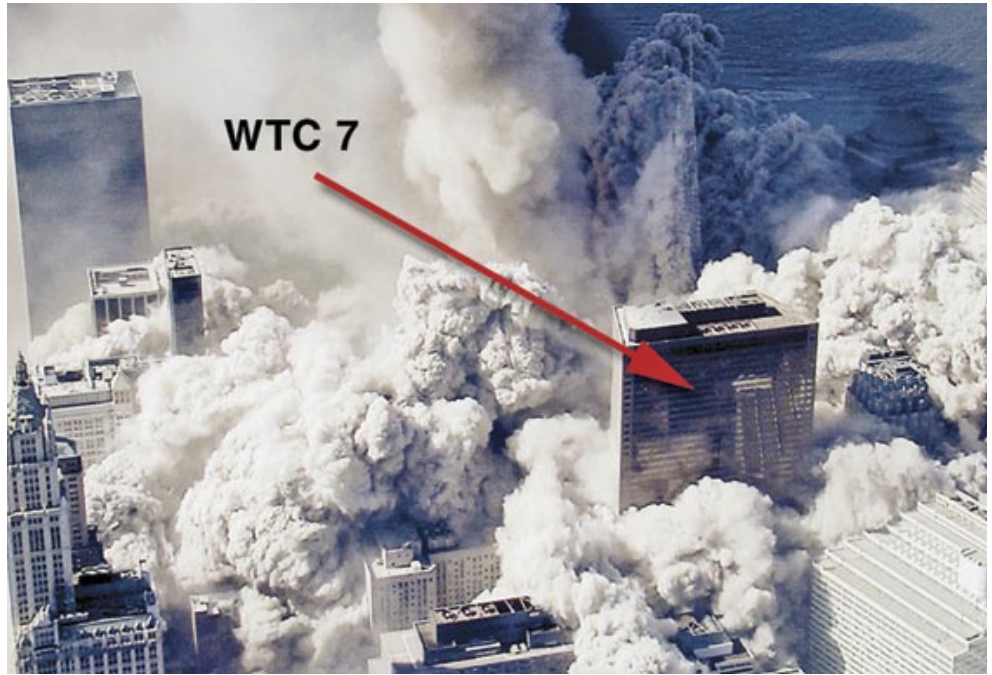
Building 6 had stood in the next block until it was turned into a crater by an unexplained huge blast after 9am.

Why indeed did Building 7 suddenly collapse into a neat heap at 5.20pm?

Larry Silverstein, leaseholder of the WTC, provides the answer in his order to "pull" the building!

"pull" - a term for controlled demolition

Insurance



In the documentary "America Rebuilds", aired September 2002, Silverstein makes the following statement;

"I remember getting a call from the, er, fire department commander, telling me that they were not sure they were gonna be able to contain the fire, and I said, '**We've had such terrible loss of life, maybe the smartest thing to do is pull it.**' And they made that decision to pull and we watched the building collapse."

Controlled demolition. This requires months to plan the size and placement of charges calculated for a complex building. Impossible to carry out in a few hours on a day such as 9/11. **The demolition charges must have been planned and installed in advance.**

Larry Silverstein bought WTC on 23rd July, seven weeks before 9/11 and insured it against terrorist attack for 3.2 billion. He claimed 7 billion insurance because of the double attack.

Why did they collapse?

Professor David Ray Griffin

9/11 Commission answer:

'Intensity of fire caused collapse'. Making these allegedly the first steel-frame high rise buildings in the world to collapse from fire.

BUT...

The Commission failed to mention that **prior to 9/11, fire had never caused steel-frame high-rise buildings to collapse**, even when the fires were much bigger, hotter, and longer-lasting than the fires in the towers. It did not mention, in other words, that **all previous collapses had been caused by carefully placed explosives** in a process called controlled demolition.

"We've just had another explosion."

"Why Indeed did the WTC Towers Collapse?"

WTC CCTV inoperative Sept 8-9, (the w/e before 9/11) during installation work. Opportunity to lay explosives?

Scott Forbes, a senior database administrator for Fiduciary Trust, Inc. said a cabling upgrade to increase the WTC's computer bandwidth ... began early Saturday morning (September 8th) and continued until mid-Sunday afternoon (September 9th) – approximately 30 hours. As a result of having its electricity cut, **the WTC's security cameras were rendered inoperative, as were its I.D. systems ...**

Destruction of evidence

In an article published on January 3 of 2002, James Quintiere, a Professor of Fire Protection Engineering at the University of Maryland, pointed out that **fires could not have destroyed Twin Towers and Building 7. He lamented the recycling of the evidence**, and called for a genuine investigation.

In the January 2002 issue of Fire Engineering Magazine, editor Bill Manning published an scathing attack on the destruction of WTC evidence, "Selling Out the Investigation", in which he called FEMA's **"official investigation" a "half-baked farce"**.

All WTC steel-work except some selected pieces were **shipped to China for recycling**, prior to the 9/11 Commission Inquiry which eventually started in March 2003.

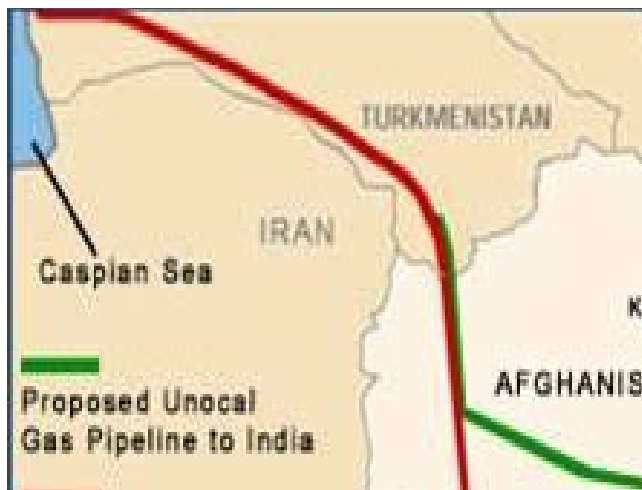
The document states:

<p>Independent Research</p>	<p>There has been a great deal of investigating and putting together evidence. The official story doesn't hold up to scientific scrutiny and very different perspectives have emerged.</p>
